About this Program:

Dr. Eric Oberlander is a neurosurgeon with the Neuromedical Center in Baton Rouge. He is also affiliated with Cypress Pointe Surgical Hospital in Hammond. He is also affiliated with LSU athletics as a team neurosurgeon. Dr. Oberlander is a premier and highly sought after neurologist treating patients throughout the State of Louisiana and across the nation. Dr. Oberlander will discuss recent innovations in neurosurgery, neuroradiology, pain management and physical medicine

Dr. Nathaniel Rawicki, is a graduate of Pepperdine University in sports medicine, a graduate of New York Medical College Orthopedic Residency Program, along with other training in Spine Surgery completing the John H. Moe Fellowship program. He is a surgeon specializing in the treatment of all spinal disorders, with a particular interest in both minimally invasive spine surgery, as well as complex spinal deformity and revision procedures. Dr. Rawicki will discuss interventional pain and neurosurgery, particularly the lumbar area. He will address particular cases in neurosurgery, how a neurosurgery consult can benefit a chiropractic patient and the misconception that only surgical patients can benefit from the consult.

Dr. Matthew Bernard is an emergency room physician. Dr. Bernard is affiliated with multiple hospitals, including Ochsner Medical Center-Kenner and New Orleans East Hospital. He is currently a principal physician at St. Tammany Trace ER. Dr. Bernard will discuss emergency medicine, typical presentations which require emergency care, methods of referral to the emergency room, patient presentation and referral back for chiropractic care. He will also discuss MRI reads and their use and utility in the emergency setting

Dr. Michael Collins is a Board-Certified spine surgeon with Ponchartrain Orthopedics and Sports Medicine. Dr. Collins is skilled in both traditional and minimally invasive approaches to the Spine. He believes in being on the cutting edge of technology in the field and uses computer guided navigation in his spinal fusion procedures. He is a certified user of the MazorX Stealth and Excelsius Spinal Robots. Dr. Collins will provide a presentation on sports medicine. He will primarily address injuries to the bones and joints and co-treatment of these injuries with chiropractic care. He will provide direction on when and methods for referral of patients with these injuries which may or may not also involve the spine.

Dr. Chad Domangue is a nationally recognized neurologist, pain management specialist, patient advocate, entrepreneur and speaker from south Louisiana. He is the co-creator of the YNRC Relation Shot for supplement therapies. Dr. Domangue will discuss recent trends in the treatment of traumatic brain injury and neurological innovations in patient care.

Tim Richardson is an attorney and holds a Masters of Business Administration. Mr. Richardson has been practicing law since 2001; practices across the state and serves as counsel for the Louisiana Sheriff's Association. Mr. Richardson keeps abreast of changes in the law; legal principals affecting chiropractors; and trends by insurers on chiropractic reimbursement. He will discuss challenges being made to chiropractic records, common mistakes made in records and what attorneys and adjustors are focusing upon when examining the documents. He will also address recent case law updates, risk management, corporate lease negotiations, non-compete clauses and person injury practice.
